Indiana Engineer of the Year Award

This award recognizes an ISPE member who has made outstanding contributions to the Engineering Profession and the community during one's career.

Qualifications: Any licensed Professional Engineer (PE) and NSPE member in good standing, is eligible for nomination. Current officers of ISPE are not eligible for nomination.

Method of Selection: Selection of the recipient based on the following criteria:

- Professional society activities, positions held, and achievements
- Technical society activities, positions held, and achievements
- Community and humanitarian activities, positions held, and achievements
- Honors, awards, and other laudatory recognition from any source
- Service to the Engineering Profession

Nomination Format: Complete nomination packets shall not exceed fifteen (15) 8.5" x 11" pages. Submissions must include the attached Nomination Form as the cover page. This form and all accompanying sheets – except for supporting documentation -- shall be typed in 11-point Arial font. Supporting pages shall identify to which of the five criteria categories each applies. Lastly, please provide a statement of 500 words or less, which is suitable to be used as a press release that provides an overview of the nominee's achievements and summarizes why the nominee is deserving of this award. Provide at least two media outlets to which this statement should be sent if the nominee is selected for this award.

All entries must be in a single MS Word or PDF file and be submitted electronically as an attachment to an e-mail sent to info@indspe.org.

Deadline to Submit Nominations: April 15

Presentation: The award will be bestowed at the ISPE Annual Conference in June.

Indiana Engineer of the Year Award Criteria

Minimum Requirements: Must be a registered Professional Engineer in the State of Indiana. The nominee must be an NSPE member in good standing.

Evaluation Criteria: The Awards committee members will evaluate the nominee based on the five criteria categories and score each with a maximum amount of points based on the following table.

| Criteria Category | Maximum Points |
|---|-----------------------|
| Professional society activities, positions held, and achievements | 10 |
| Technical society activities, positions held, and achievements | 10 |
| Community and humanitarian activities, positions held, and achievements | 20 |
| Honors, awards, and other laudatory recognition from any source | 20 |
| Service to the Engineering Profession | 40 |
| Total for all Categories | 100 |

Indiana Engineer of the Year Award Basis for Nomination

- **1. Professional society activities, positions held, and achievements:** These should include any non-technical organizations (e.g. NSPE, SWE, NSBE, and SHPE) at the national, state, and local level. Include affiliations, positions held, awards received, notable achievement, etc.
- **2. Technical society activities, positions held, and achievements:** Representative organizations in this category include the founding societies (e.g. ASCE, ASME, and IEEE) and any others for which the nominee's technical prowess is applicable. Include affiliations, positions held, awards received, notable achievement, etc.
- **3. Community and humanitarian activities, positions held, and achievements:** This category includes a wide swath of organizational activities, including service organizations, scouting, governmental service, religious organizations, and others intended to assist people and/or improve quality of life. Include affiliations, positions held, awards received, and noteworthy achievements with explanation of each's significance in the particular activity, etc.
- **4. Honors, awards, and other laudatory recognition from any source:** Recognition from any source that acknowledges the achievements of the nominee should be included in conjunction with emphasis on service to the Engineering Profession. Particular emphasis will be accorded such recognition on the international or national level. The reputation of the source of the honor will also be considered.
- **5. Service to the Engineering Profession:** Service to the profession will be evaluated on the basis of a broad range of achievements that (1) have advanced the reputation of the Engineering Profession with stakeholders outside the Profession, e.g. the Public, governmental entities, and the educational community, (2) have facilitated improved performance of organizations that support the advancement of the Engineering Profession; and (3) that made the Engineering Profession a more desirable career path for aspiring engineers. This is the most significant category for scoring.
